

## MONTHLY COFFEE REPORT-DECEMBER 2025

## COFFEE YEAR 2025/26- ISSUE 3

### Key Highlights

A total of 502,582 60-kilo bags of coffee valued at US\$ 149.87 million (UGX 535.80 billion) were exported in December 2025 at an average price of US\$ 4.97/kilogram, US cents 13 higher than US\$ 4.84/Kilogram in November 2025, and US cents 33 higher than the US\$ 4.64/kilogram in December 2024. This was an increase of 22% and 30% in quantity and value respectively compared to the same month last year.

Farm-gate prices for Robusta Kiboko averaged UGX 6,750/= per kilogram; FAQ UGX **13,500** per kilogram, Arabica parchment UGX **16,750** per kilogram and Drugar UGX **16,500** per kilogram. Rwenzori AA had the highest price registered. (US\$ 13.34 per kilogram).

Coffee exports for twelve months (Calendar year 2025) totaled 8.7 million bags worth US\$ 2.5 billion (UGX 8.9 Trillion) compared to 5.9 million bags worth US\$ 1.4 billion (UGX 5.4 trillion) in the previous year (Calendar year 2024). This represents an increase of 48% and 71% in quantity and value respectively.

54% of the total export volume was exported by top 10 exporters, out of 85 companies which performed during the month compared to 64% in the month of November 2025. (Annex 1)

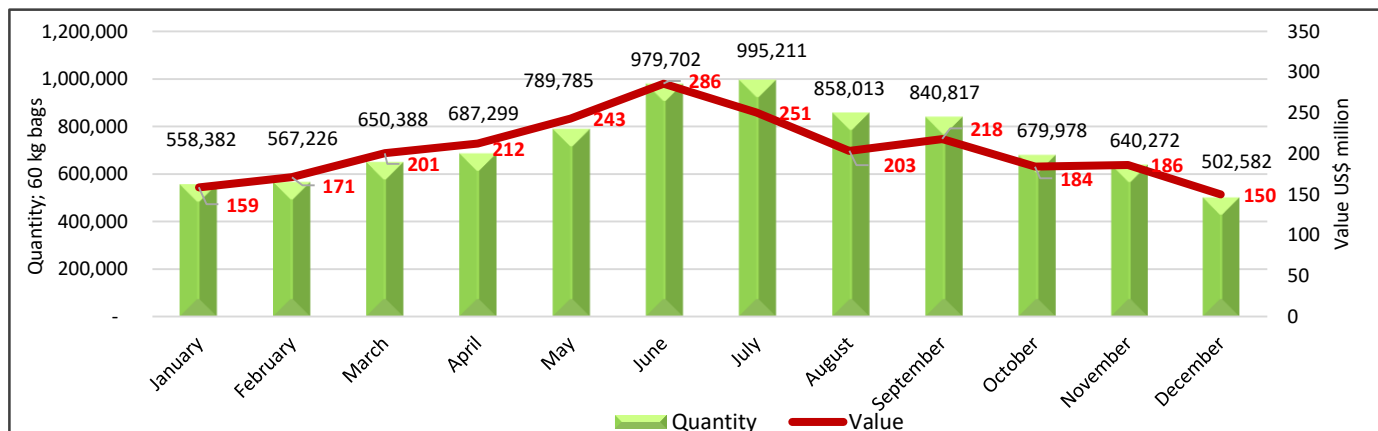
### 1. Coffee exports

Coffee exports in December 2025, totaled to 502,582 60-kilo bags worth US\$ 149.87 million (UGX 535.80 billion). This comprised of 367,627, bags of Robusta valued at US\$ 94.64 million (UGX 338.35 billion) and 134,955 bags of Arabica valued at US\$ 55.23 million (UGX 197.45 billion) (see Table 1). This was an increase of 22% and 30% in quantity and value respectively compared to the same month last year (December 2024). Robusta increased by 0.1% in quantity decreased by 5.3% in value, while Arabica exports increased by 186% and 265% in quantity and value respectively.

Coffee export volume were higher than the previous year on account of increased coffee production. Coffee prices at the global moved lower which was mainly driven by an improved global supply outlook.

Coffee exports for twelve months (Calendar year 2025) totaled 8.7 million bags worth US\$ 2.5 billion (UGX 8.8 Trillion) compared to 5.9 million bags worth US\$ 1.4 billion (UGX 5.2 trillion) in the previous year (Calendar year 2024). This represents an increase of 48% and 71% in quantity and value respectively.

## 2. Exports by Type and Grade

**Table 2** shows coffee exports by type, grade and average price realized for each grade during the month of December 2025. The average export price was US\$ 4.97 per kilogram, US also US cents 33 higher than in December 2024 (US \$ 4.64/kilogram). Robusta exports accounted for 73% of total exports, lower than 80% in November 2025. The average Robusta price was US\$ 4.29 per kilogram, the same as November 2025. The highest price was for Washed Robusta sold at US\$ 5.01 per kilogram, followed by Screen 18 sold at US\$ 4.54 per kilogram.

The share of Sustainable/washed coffee to total Robusta exports was 0.1% lower than 0.71% in November 2025. Arabica fetched an average price of US\$ 6.82 per kilogram US cents 56 higher than the previous month (US\$ 7.01). The highest price was for Rwenzori AA sold at US\$ 13.34 per kilogram. It was followed by Mt. Elgon A+ sold at US\$ 8.24 per kilogram. Drugar was sold at US\$ 7.13 per kilogram, 24 cents higher than US\$ 6.89 per kilogram the previous month, and was 27% of total Arabica exports lower than 47% the previous month. The share of sustainable Arabica exports to total Arabica exports was 5%, the same as November 2025.

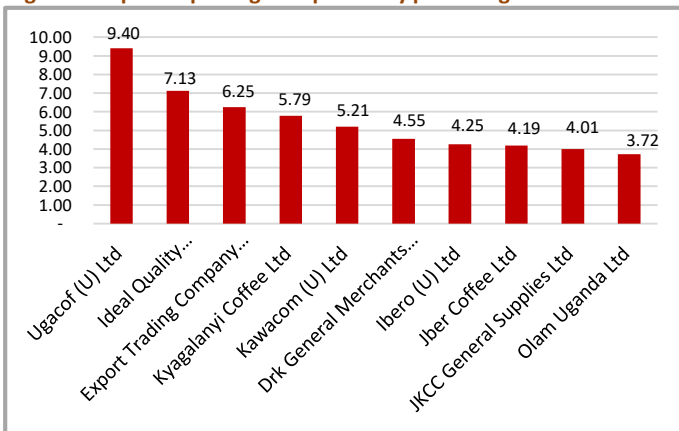

## 3. Individual Exporter Performance

**Figure 2** shows the top 10 export companies' performance in the month of December 2025. Ugacof (U) Ltd had the highest market share of 9.40% compared to highest of 17.25% in November 2025. It was followed by Ideal Quality Commodities Ltd 7.13% (3.93%), Export Trading Company (U) Ltd 6.25% (67.11%), Kyagalanyi Coffee Ltd 5.79% (8.42%), Kawacom U) Ltd 5.21% (53.54%), DRK General Merchants Ltd 4.55% (3.63%), Ibero (U) Ltd 4.25% (3.40%), Jber Coffee Ltd 4.19% (6.54%), JKCC General Supplies Ltd 4.01% (3.81%) and Olam Uganda Ltd 3.72% (3.30%) *\*The figures in brackets represent percentage market share held in November 2025.* The top 10 exporters held a market share of 54% lower than 66% the previous month reflecting competition at exporter level. Out of the 85 exporters who exported, 31 exported Robusta Coffee only while 20 exported Arabica coffee only. **Annex 1** shows a detailed list of exporters' performance in December 2025

**Figure 2: Top 10 Exporting Companies by percentage market share**



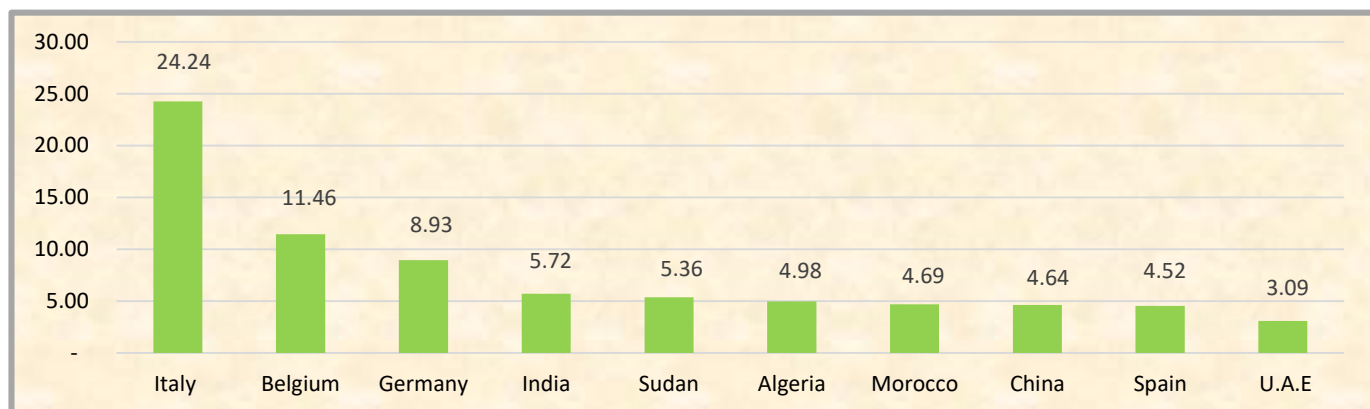
#### 4. Coffee Exports By Destination

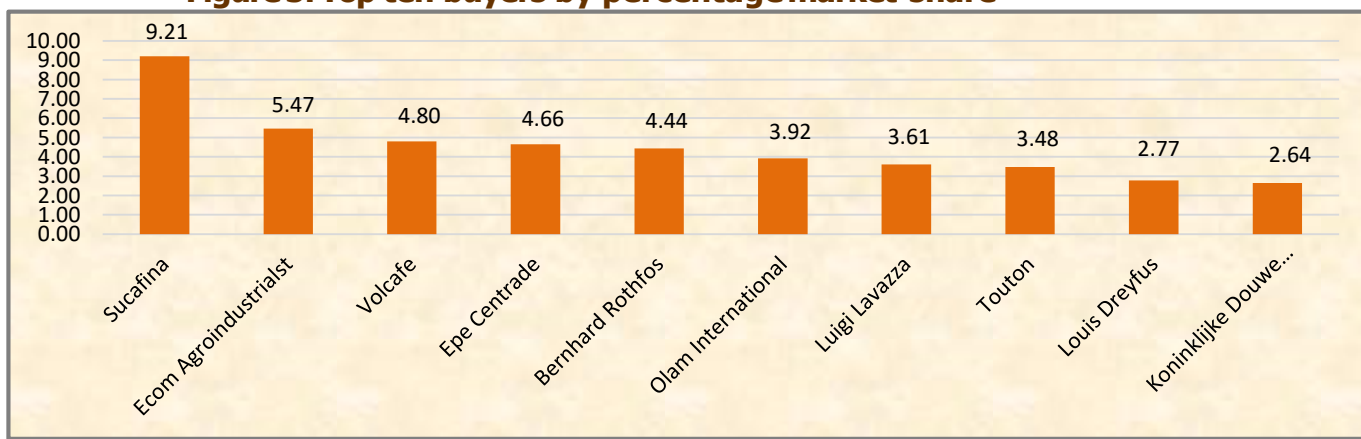
**Figure 3: Top ten export destinations by percentage market share**

The destinations of Uganda's coffee exports during the month of December 2025 are shown in **Fig 3** (details in **Annex 2**). Italy remained with the highest market share of 24.24% compared to 25.80% last month. It was followed by Belgium 11.46% (5.30%), Germany 8.93% (14.01%), India 5.72% (7.13%), and Sudan 5.36% (2.02%). *\*The figures in brackets represent percentage market share held in November 2025.* The first 10 major destinations of Uganda coffee took a market share of 78% compared to 76% the previous month. Coffee exports to African countries totaled 79,079 bags, a market share of 16% compared to 55,671 bags (9%) the previous month. African countries that imported Uganda coffee included; Sudan, Algeria, Morocco, Kenya, South Africa, Egypt and Madagascar. Europe remained the main destination for Uganda's coffees with a 62% import share, higher than November 67% in 2025.

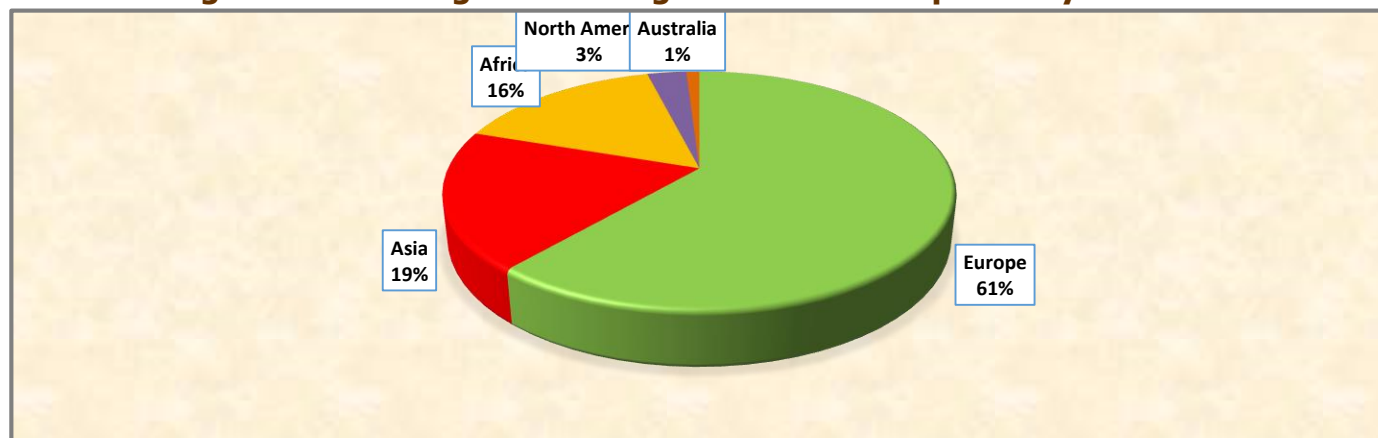
#### 5. Foreign buyers of Uganda Coffee

**Annex 4** shows a list of Uganda coffee foreign buyers in December 2025. The top 10 buyers held a market share of 44.98% lower than 56.11% the previous month. Sucafina led with a market share of 9.21% compared to 17.44% in November 2025. It was followed by Ecom Agroindustrialst with 5.47% (4.05%), Volcafe 4.80% (5.62), Epe Centrade 4.66%, Bernhard Rothfos 4.44% (4.06%), Olam International 3.92% (3.50%); Luigi Lavazza 3.61% (0.73%), Touton SA 3.48% (8.08%), Louis Dreyfus 2.77% (3.66%) and Koninklijke Douwe Egberts 2.66% (2.87%); *The figures in brackets represent percentage marketshare held in November 2025.*

## 6. Global Situation

World coffee production for 2025/26 is forecast 3.5 million bags higher than the previous year to a record 178.8 million due to continued recovery in Vietnam and record output in Indonesia and Ethiopia, more than compensating for losses in Brazil and Colombia. World coffee bean exports are forecast 2.3 million bags higher to 123.8 million as gains from Vietnam, Indonesia, and Honduras more than offset losses from Brazil and Colombia. With global consumption continuing to rise to a record 173.9 million bags, ending stocks are expected to drop for a fifth-consecutive year to just 20.1 million bags. In response, coffee prices as measured by the International Coffee Organization (ICO) monthly composite price index have nearly tripled during this period. (United States Department of Agriculture, Coffee: World Markets and Trade report-December 2025).

## 7. Local Situation

During the month of December 2025, farm gate prices ranged from UGX 6,500-7,000 per kilogram of Kiboko (Robusta dry cherries); UGX 13,000-14,000 for FAQ (Fair Average Quality); UGX 16,500-17,000 for Arabica Parchment; and UGX 16,000-17,000 per kilogram for Drugar. Robusta Kiboko averaged UGX 6,750 per kilogram the same as the previous month, Robusta FAQ averaged UGX 13,500 lower than UGX 14,750 per kilogram, Arabica parchment UGX 16,750 per kilogram, higher than UGX 16,500 per kilogram the previous month. Drugar UGX 16,500 per kilogram the same as the previous month.

## 8. Coffee Development Activities

In December, extensive efforts were undertaken to strengthen coffee production, productivity and improve coffee quality across the country. A total of 105 coffee farmer trainings were conducted nationwide, reaching 2,791 farmers, including 2,005 men, 786 women, 474 youth, 32 PWDs and 329 elderly farmers, reflecting a commitment to inclusive sector development.

The trainings focused on coffee establishment and farm management, covering critical practices such as proper planting and spacing, selection of quality planting materials, shade management, intercropping, and management of newly planted coffee. Farmers were also guided on recommended post-harvest handling practices aimed at enhancing coffee quality and market competitiveness.

To reinforce on-farm support, 232 farm visits and inspections were conducted across Uganda, reaching 921 farmers. These engagements enabled the identification of key production challenges, notably the continued prevalence of pests and diseases. In response, farmers received targeted technical guidance on moisture stress management, as well as weeding, pruning, stumping, and the adoption of climate-smart agricultural practices.

Rehabilitation of aging coffee gardens remained a priority during the month, with 97,349 coffee trees stumped by 1,047 farmers, including 575 men and 472 women, to restore productivity in old and unproductive plantations. In support of improved yields and soil health, 34,372 bags of organic fertilizer were distributed to 9,521 farmers across targeted regions.

Quality assurance and regulatory oversight activities were also strengthened through inspections of 128 hullers, 157 buying stores, 15 grading facilities, and 18 wash stations, alongside the installation of 10 new washing stations and factories. Additionally, five post-harvest handling and Good Manufacturing Practices (GMP) training sessions were conducted in Greater Mpigi, Elgon, Northern, and Kigezi, reaching 275 participants.

Licensing and enforcement activities during the period covered 60 hullers, 52 buying stores, 4 wash stations, 1 roaster, and 1 grading facility. Quality assurance efforts included the collection of 22 coffee samples for laboratory analysis, support to 96 traders and processors, and the installation of three solar dryers to improve drying efficiency and quality.

## 9. Outlook for January 2025

Uganda's Coffee exports are projected to reach 420,000 60-kilo bags in January 2025. The main harvest season in parts of Central and Eastern Regions has ended.
